5 About the TMD

6 Target Market

6.1 Description of target market

The features of this product have been assessed as meeting the likely objectives, financial situation and needs of consumers who:

- are:
 - o at least 18 years old:
 - o individual borrowers (as single or joint borrowers); and
 - an Australian Citizen or a Permanent or Temporary Resident of Australia with an Acceptable Visa that does not reside in Australia or a New Zealand Citizen that does not reside in Australia or New Zealand;
- require a loan to purchase or refinance an investment property and who may also wish to release some of the equity in their property for other purposes such as to consolidate debt or to be used for personal or investment purposes;
- require an offset account;
- require the flexibility of a variable interest rate;
- require the ability to make additional extra repayments without penalty;
- want the option of either principal and interest or interest only repayments for a period of time; and
- satisfy our eligibility criteria;

Although variable interest rates fluctuate, the product meets the likely objectives, financial situation and needs of consumers in the target market because it allows them to deposit funds into an offset account and/or make additional payments directly into the loan to reduce the amount of interest payable whilst maintaining the ability to draw on surplus funds when required. This product also allows consumers to select interest only or principal and interest repayments in order to reduce their overall debt and build equity.

6.2 Classes of consumers for who the product may not be suitable

This product may not be suitable for consumers who:

- · do not meet the eligibility requirements;
- are seeking the certainty of fixed repayments over a period of time;
- are looking to purchase or refinance a residential owner occupied property;
- are looking to construct a property; or
- are an Australian Citizen or a Permanent or Temporary Resident of Australia that resides in Australia or a New Zealand Citizen that resides in Australia or New Zealand.
