5. About the TMD

This TMD aims to provide an understanding of the class of customers we have designed this product for, being the target market. When considering the target market, we focused on our customers' objectives, financial situation, and needs within this class of people we believe this product to be suitable.

6.1 Description of target market

The features of this product have been assessed as meeting the likely objectives, financial situation and needs of consumers who:

- are:
- are:
 - o at least 18 years old;
 - individual borrowers (as single or joint borrowers);
 - Non-resident applicants may require approval from the Foreign Investment Review Board (FIRB) before they can purchase real estate;
 - Salary and Wage earners (Employees) and Self-Employed Consumers only (Company and business borrowers are excluded);and
 - Only to borrowers situated in "Approved Countries" in accordance with our Credit Policy;
- require a loan to purchase or refinance an investment property;
- require an offset account;
- require the certainty of a fixed interest rate for a period of time;
- are able to make up to \$20k per annum of extra repayments without penalty;
- want the option of either principal and interest or interest only repayments; and
- satisfy our eligibility criteria;

The product meets the likely objectives, financial situation and needs of consumers in the target market because it provides them with the certainty of a fixed rate for an initial period of time, allows them to deposit funds into an offset account and/or make additional payments directly into the loan to reduce the amount of interest payable up to \$20k additional per annum whilst maintaining the ability to draw on surplus funds when required. This product also allows consumers to select interest only or principal and interest repayments in order to reduce their overall debt and build equity.

6.2 Classes of consumers for who the product may not be suitable

This product may not be suitable for consumers who:

- do not meet the eligibility requirements;
- are looking to purchase or refinance an existing residential owner occupied property;
- are looking to construct a property; or
- want to make more than \$20,000 per annum in extra repayments on the loan;
- are an Australian Citizen or a Permanent or Temporary Resident of Australia that resides in Australia or a New Zealand Citizen that resides in Australia or New Zealand.
