5. About the TMD

This Target Market Determination (**TMD**) document is not intended to provide financial advice. Please refer to our Terms and Conditions and Credit Guide before deciding product suitability. Our product terms and conditions will be provided to you upon request.

This TMD aims to provide an understanding of the class of customers we have designed this product for, being the target market. When considering the target market, we focused on our customers' objectives, financial situation, and needs within this class of people we believe this product to be suitable.

6. Target Market

5.1 Description of target market

The features of this product have been assessed as meeting the likely objectives, financial situation and needs of consumers who:

- are:
 - o at least 18 years old;
 - o individual borrowers (as single or joint borrowers); and
 - o an Australian citizen or a permanent Australian resident;
- require a finance facility to purchase or refinance an owner-occupied property and who may also wish to release some of the equity in their property for other purposes such as to consolidate debt or to be used for personal or investment purposes;
- require an offset account;
- require the certainty of a fixed rental rate;
- are able to make up to \$20k per annum of extra payments without penalty;
- want the option of either principal and rental payments or only rental payments for a period of time; and
- satisfy our eligibility criteria;

The product meets the likely objectives, financial situation and needs of consumers in the target market because it provides them with the certainty of a fixed rate for an initial period of time, allows them to deposit funds into an offset account and/or make additional payments directly into the Finance facility to reduce the amount of rental rate payable up to \$20k additional per annum whilst maintaining the ability to draw on surplus funds when required. This product also allows consumers to select rental only payments or principal and rental payments in order to reduce their overall debt and build equity.

5.2 Classes of consumers for who the product may not be suitable

This product may not be suitable for consumers who:

- · do not meet the eligibility requirements;
- are looking to purchase or refinance a residential investment property;
- are looking to construct a property; or
- want to make more than \$20,000 per annum in extra payments on the finance facility.
